



Gifts of Securities Donor Instructions

Significant tax savings occur when you donate publicly traded securities directly to the Archdiocese or your parish. Securities include stocks, bonds and mutual funds. Securities received by the Archdiocese are sold and the cash proceeds are used according to your wishes.

How to Make a Gift of Securities to the Archdiocese or your parish:

1. Notify the Archdiocese of your intention

When planning to make a gift of securities to the Archdiocese or your parish, please notify the Development Office at the Archdiocese at 604-683-0281 or development@rcav.org. You will need to provide written intent with the Gift of Securities Authorization Form stating where the cash proceeds from your gift are to be directed.

2. Advise your broker

Advise your broker that you would like to make a gift of securities through a direct transfer to the Archdiocese of Vancouver. If your broker requires a written letter of direction you can refer to the Archdiocese of Vancouver Gifts of Securities Authorization form attached.

3. Charitable tax receipt

Shares received by the Archdiocese are immediately sold and the net proceeds are directed to the parish or Archdiocesan priority according to your wishes. Please note that **brokerage commission may be charged by the Archdiocesan broker when the shares are sold**. You will receive a charitable tax for the close value of your securities on the date they are received into the Archdiocesan brokerage account.
